TOURNAMENT SITE: Maui Bowling Center, 1976 Vineyard Street, Wailuku, Maui Hi 96793

ELIGIBILITY: Open to all bowlers fifty (50) years of age and older as of the tournament date. The Divisions shall be as follows: Division A - 50 – 55 years of age; Division B – 56 – 62 years; and Division C – 63 years and older, or to divide Division B & C equally according to age. With the submission of this entry, we agree to abide by the rules set forth and shall possess a valid and current USBC card. USBC card shall be presented at time of check-in.

ENTRY DEADLINE: August 10, 2017 or to the first sixty paid entries. Any checks returned from the bank, for whatever reason will be assessed a \$25.00 fee and we will not accept any check from this individual hereafter. Must be paid in full at time of submission of entry form or a late charge fee of \$10.00 will be added at tournament site.

NO CHECKS WILL BE ACCEPTED AT TOURNAMENT SITE.

ENTRY FEES/PRIZE FUND: Entry Fee into this tournament is \$50.00 per participant. All awards in all divisions shall be based on total pin fall with handicap. Should there be a TIE in any division, the prize fund shall be divided equally. 100% of the prize fund will be returned. Prize fund ratio is: 1: 2 entries in each division(s). **There will be no refunds upon acceptance of the participant's entry. ALL WINNERS MUST CASH THEIR CHECKS WITHIN 90 DAYS UPON RECEIVING.**

HANDICAP: Based on 80% of 200

AVERAGE QUALIFICATIONS: Determined in the following order:

- A. Highest Ave of B, C, or D. Rule 319-a.
- B. Completed/Current average of 21 games or more as of July 31, 2017.
- C. Average Book for 2015 – 2016.
- D. Current average book for 2016 – 2017 (on availability)
- E. All bowlers not meeting the above requirements shall enter as: Men at 170; Women at 150.

CAUTION: Submitting a correct average is the **bowler's responsibility**. Failure to use the correct average shall **DISQUALIFY** score if submitted average is lower than correct average thereby resulting in a lower classification or more handicaps. Prize winnings shall be based on the submitted average if it is higher than the correct average. However, corrections in averages may be permitted up to the completion of the first game of a series. See USBC Rule 319a. The "ten pin or more increase in average" provision – USBC tournament. **WARNING:** All participants are cautioned to be familiar with the average adjustment requirement of USBC Rule 319e. This rule applies to all Men and Women participants. All rules not mentioned shall be governed by the USBC Tournament Rules and Regulations.

DISCREPANCIES: The decision of the tournament chairman shall be final unless an appeal is made in accordance with Rule 329.
